Status and plans of web-based Marine Facilities Program (MFP)

- AAD (Australian Antarctic Division, Tasmania) is now an official user (signed contract); they
 use the inventory management only for the time being. CSIRO (also Tasmania) is planning to use
 the full MFP system. They now have a paid test account on a dedicated server located in
 Australia.
- NSF (USA) is also planning to use the application / cruise planning tool. They currently have a test account.
- IMR (Norway) has not the manpower to set it up by now.
- CSIC (Spain) is planning to use the MFP very soon.
- BSH (Germany) is also interested to use the MFP.
- MFP has got a major update with several new functions. Furthermore, a new MFP phone app with full scanner functionality is now available. This increases the potential for the use of the OFEG group (e.g. port notes).
- P&O maritime has asked for information
