The system based mainly on NMEA messages as main data source and Java-scripts. It contains standard ports. For the sensor measurements the NMEA protocol uses Marpol or Scanmar.

• Cruise programs for 2019/2020 were presented by the OFEG partners. Cruise programs are uploaded on OFEG website as far as they have been published (see 'Ship Schedules').

# Status and plans of web-based Marine Facilities Program (MFP)

- AAD (Australian Antarctic Division, Tasmania) is now an official user (signed contract); they use the inventory management only for the time being.
- CSIRO (also Tasmania) is now also an official user with a signed contract, planning to use the full MFP system. Both Australians groups use a dedicated server located in Australia.
- CSIC (Spain) is planning to implement the use of MFP this Summer, before September.
- IMR (Norway) has not the manpower to set it up for now.
- SYKE (Finland) has made the decision to use MFP. Because of budget constraints caused by problems with the vessel implementation has been postponed until next year.
- NSF (USA) is also interested in using MFP. They have had a test account and the new UNOLS office has now taken this up.
- MFP has a lot of new functionality in the program construction module with options to select applications from the map. The option to select nearby ports from the map and to get additional info for these ports (earlier vessel dockings and inserted notes on ports and agents) increases the potential for the OFEG group. The MFP phone app now has full scanner functionality.
- There have been discussions with other interested parties: NIWA (New Zealand), BSH (Federal Maritime Hydrographic Agency of Germany), Shipping Company Briese (Germany), P&O (Ireland), JAMSTEC. Follow-up: we will see. Once CSIRO has implemented MFP, NIWA is likely to follow.
